# Plenary Session 1. Global and regional socioeconomic developments: a perfect storm



#### **Sabine Oueiss**

Sabine Oueiss is a columnist, and business and political editor at An-Nahar Newspaper since 1997. She was a Talk Show Host for 7 years (2005–2012) at Future Television and contributed to the Arabic edition of global media outlets including the "Independent Arabia", (till 2018). She is a lecturer in economics and development at An-Nahar Academy among several other media institutions, and Author for several books on the dynamics of the local banking and industrial sector. She is the President of the Association of Economic Journalists and a Public Relations consultant for leading Lebanon-based companies.



#### **David Nabarro**

David Nabarro is Co-Director of the Institute of Global Health Innovation and Professor of Global Health at Imperial College London. He established the Geneva-based foundation Skills, Systems and Synergies for Sustainable Development (4SD) with Florence Lasbennes in 2018. 4SD accompanies development practitioners as they advance the transformation of complex people-centred systems. Through 4SD, Nabarro has served as Special Envoy of the World Health Organization (WHO) on COVID-19 (since early 2020) and has led the Food Workstream in the United Nations Global Crisis Response Group on Food, Energy and Finance (GCRG) since March 2022: this equips the United Nations to respond to uneven pressures being faced by people and nations due to increases in the cost of living, exacerbated by the war in Ukraine.



#### **Fayza Shaheen**

Fayza Shaheen is the Inequality and Exclusion Program Lead for the Pathfinders for Peaceful, Just and Inclusive Societies. An economist, writer, activist and commentator, she has published on inequality, austerity, immigration, youth unemployment and social mobility. She served as Director of the Centre for Labour & Social Studies, Head of Inequality and Sustainable Development at Save the Children in the United Kingdom, and Senior Researcher on economic inequality at New Economics Foundation. In 2017, Shaheen was named Observer's Rising Star for campaigning, nominated as Asian Woman of the Year and included in the Top 100 Influencers on the Left list in the United Kingdom.



### **Barbara Adams**

Barbara Adams is President of Global Policy Forum and part-time Professor at the New School. Trained as an economist, Barbara Adams' experience and expertise have many facets – as a researcher and teacher, as a civil society organizations policy advocate, and with a long tenure working for the United Nations. A consistent theme has been rights and justice in multilateralism, governance and sustainability. She has authored and co-authored many articles, reports, commissioned studies and books, and is a regular contributor in the Global Policy Watch briefings series and the annual Spotlight Report on Sustainable Development. Publications include: Accounting for Africa at the United Nations: A Guide for Non-Governmental Organizations; Putting Gender on the Agenda; Climate Justice in a Changing World, co-authored with Gretchen Luchsinger; Reclaiming Multilateralism for People, Rights and Sustainable Development; Whose Development, Whose UN?; and Fit for Whose Purpose?, co-authored with Jens Martens. She has been the author of a chapter in the Routledge Handbook on the UN and Development and is the guest editor for a special edition of the Journal Development.



## **Attiya Waris**

Attiya Warris is the current United Nations Independent Expert on Foreign Debt and other related international financial obligations of States on Human Rights and is the only Professor of Fiscal Law and Policy in Eastern Africa. She is a Commissioner on the Lancet-O'Neil Commission on racism and Structural Discrimination in Health and Chairs the Supervisory Board of the Capabuild Foundation. She holds a PhD in Law and is a specialist in fiscal law, policy and development. She is an advocate, company secretary and arbitrator of 20 years standing. She has published widely, most notably her book "Tax and Development" (2013) is the first publication globally that links the areas of tax and human rights and her more recent publication "Financing Africa" (2019) is the first publication globally to map out African fiscal systems.



## Ahmad Majdalani

Ahmad Majdalani is the Minister of Social Development in the State of Palestine. He served in many positions and was the General Secretary of the Palestinian Popular Struggle Front, A member of the Executive Committee of the Palestinian Liberation Organization, and Chairperson of the Palestinian Planning and labor Department. He holds a bachelor's degree in Political Sciences and PhD in Economic Philosophy. He is the author of various studies and research. Supervised many projects in Ramallah like Institutional Support to the Palestinian Agricultural, the the National Conference For Enhancing, Integrity, Transparency and Accountability in the Palestinian society (AMAN), a study on the infrastructure investment in the State of Palestine, etc.
