UN Decade on Ecosystem Restoration – What does it mean for our region.

Tuesday, 15 March 2022, 14:45 – 16:15 pm, Beirut time

Background

Co-led by the United Nations Environment Programme (UNEP) and the Food and Agriculture Organization of the United Nations (FAO), to build a strong and widerange global movement, the United Nations General Assembly announced 2021–2030 as the UN Decade for Ecosystem Restoration (UNDER). The UN Decade aims to build a strong, broad-based global movement to ramp up restoration and prevent, halt and reverse degraded and destroyed ecosystems worldwide. It acts as a framework for action to "revitalize" existing environment-related international agreements and commitments and put the world on track for a sustainable future.

In the Arab region, ecosystems are under serious threat, adding to the already existing water scarcity, aridity, and land degradation. Fisheries in the region are often associated with the unsustainable use and depletion of marine resources. Climatic extremes - particularly drought, flash floods, sand and dust storms and the increasing frequency and intensity of forest and wildfires- in addition to conflicts and forced migration aggravate vulnerabilities of the ecosystems and weaken their role in sustaining the livelihoods of millions of people. Land degradation has reduced the potential productivity of soils by about a third over recent years, and the region lost 2.8 million ha of its forest cover during the last thirty years, equivalent to an annual loss of 95,000 ha. Thus, the need to adopt long-term policies and strategies for ecosystem restoration in the region is of paramount importance.

Objectives

- · Increasing awareness and understanding of the multiple benefits of ecosystem restoration and application in sustaining livelihoods in the Arab region and reporting on the costs to the region if no action is taken.
- \cdot Discussing what the UN Decade for Ecosystem Restoration means for the Arab region in terms of development of an action plan as well as expectations of countries to play a leading role in mobilizing all relevant stakeholders to prevent, halt and reverse degraded and destroyed ecosystems at the national and regional levels.
